**NOTES:**

**1. Type of Companies:**

Under the International Business Companies (IBC) regime, RAK ICC offers the following types of companies:

- Company Limited by Shares
- Company Limited by Guarantee
- Unlimited Company
- Restricted Purpose Company
- Segregated Portfolio Company

**2. Terms of Urgent Fees:**

- Urgent fees **do not apply** to applications related to agent registration, company liquidation, or re-domiciliation.
- Urgent fees **do not apply** to new incorporations, company registration renewals, or company amendments involving more than three shareholders.
- Applications requesting urgent (same-day) processing must be submitted **before 12:00 noon** on the required day.

**3. Differential Price:** RAKICC conducts ongoing risk assessment and monitoring of high-risk companies in its registry. Only entities that require enhanced due diligence (EDD)—such as deeper reviews, investigations, or monitoring—are charged a Differential Price (DP). This is in addition to the fees of incorporation/renewal/registration/etc.

**4. Fines:**

Fines for contraventions of the RAK ICC rules and regulations shall apply in accordance with the standard fines schedule, as outlined below:

Level of scale	Amount (AED)
Level 1	1000
Level 2	2000
Level 3	5000
Level 4	10000
Level 5	20000

**5. Penalties upon Late Renewal of an Entity:**

- An entity that is due for registration renewal must complete the renewal within **one (1) calendar month** (grace period) from the expiry date of its existing registration.
- Any entity applying for registration renewal **after** the one-month grace period will be subject to penalties on a **graduated scale**, as outlined in the schedule below.

Delay Period	Applicable Charges
Second Month from date of Registration Expiry	Renewal Fees + 10%
Third Month from date of Registration Expiry	Renewal Fees + 15%

Fourth Month from date of Registration Expiry	Renewal Fees + 25%
Fifth Month from date of Registration Expiry	Renewal Fees + 50%

- At the beginning of the **sixth month** following the date of registration expiry, a **strike-off notice** will be issued to the entity.
- A **one (1) calendar month** period will follow before the formal strike-off, during which the entity may submit written representations to the Registrar and/or complete the renewal along with all applicable penalties. If no written representation is provided and/or the renewal and penalty payment is not made within **six (6) months** from the date of expiry, the entity will be formally struck off the register.
- An entity that has been struck off may be **restored to the register**, subject to the Registrar's approval and payment of all outstanding fees and penalties for the period during which it was struck off, in addition to a **flat restoration fee of AED 550**.

**6. Other General Terms:**

- Payment of fees alone does **not** constitute automatic approval or processing of an application.
- Fees and charges are **subject to change without prior notice**.
- For company incorporations, amendments, and renewal applications involving **more than three shareholders or directors**, an additional fee of **AED 200** each applies. For **corporate shareholders or directors**, the additional fee is **AED 400** each.
- Courier charges will apply based on the **weight of the documents** and the **destination**.
- For changes to share capital: To amend the **par value and/or number of shares** without altering the authorised capital, select the amendment type **“Increase in capital – par value with number of shares”** and mark **“allotting shares”** as yes. Applicable fees: **6.14 and 6.15**.
- Any fees not specifically listed for Foundations will follow the **company fee schedule**.
- For any service request not included in the fee schedule, a **standard fee of AED 1,250** will apply.
- Where more than **three activities** are selected at the **Activity Group** level, an additional charge of **AED 550 per activity** will be applied.
